Re: First Apportionment for the New Charter School Supplemental Categorical Block Grant, FY 2010-11

The purpose of this e-mail is to notify you that the California Department of Education (CDE) has sent an apportionment to the State Controller's Office for payment. This apportionment, in the amount of \$3,572,357, is made from funds provided in Provision 2 of Item 6110-488-0001 of the Budget Act of 2010 (Charter 712, Statutes of 2010). Funding is provided to new charter schools that began operation in the 2008-09, 2009-10, or 2010-11 fiscal years, and may be used for any educational purpose.
