Re: Approval of March 2012 to April 2012 Deferral Exemptions

The purpose of this e-mail is to notify you of the school districts and charter schools that have been approved for exemption from the March 2012 to April 2012 apportionment deferral enacted pursuant to the provisions of Senate Bill 82 (Chapter 12, Statutes of 2011). Specifically, SB 82 defers \$1.4 billion of kindergarten through grade12 payments from March 2012 to April 2012.

SB 82 permitted county offices of education, school districts and charter schools to apply at two different times, by June 1, 2011 and January 5, 2012, for an exemption from the March 2012 to April 2012 deferral. A total of 22 school districts and 202 charter schools were approved for exemption during these two periods.
