Re: June 2012 Deferral Exemptions

The purpose of this e-mail is to notify you of the local educational agencies (LEAs) that have been approved for exemption from the June 2012 apportionment deferral. Specifically, Assembly Bill (AB) 1610 (Chapter 724, Statutes of 2010) added California *Education Code* Section 14041.7 which provided the opportunity for school districts and charter schools to apply for a dollar-limited exemption from the deferral of the June 2012 principal apportionment payment to July 2012.

Under current law, LEAs that are exempt will receive a payment in June 2012 equal to the lesser of (1) the total amount of additional funds necessary to meet their financial obligations for the month of June 2012 as approved by the Department of Finance or (2) the total principal apportionment payment the LEA is entitled to receive in July for June.

However, AB 103ⁱ, if enacted, would change the payment amount to no more than the need of additional funds necessary to meet financial obligations for the month of June 2012 as approved by the Department of Finance.

I have attached the list for your information; however, information about the deferral process and related document can be found at http://www.cde.ca.gov/fg/fi/ir/june12deferral.asp. Seventeen school districts and 169 charter schools received an exemption.
