Re: June 2013 Apportionment Deferral Waivers

The purpose of this bulletin is to notify you of the local educational agencies (LEAs) that have been approved for exemption from the June 2013 apportionment deferral. Specifically, Assembly Bill (AB) 1610 (Chapter 724, Statutes of 2010) added California *Education Code* Section 14041.7 which provided the opportunity for school districts and charter schools to apply for a dollar-limited exemption from the deferral of the June 2013 principal apportionment payment to July 2013.

The LEAs that are exempt will receive a payment in June 2013 equal to the lesser of (1) the total amount of additional funds necessary to meet their financial obligations for the month of June 2013 as approved by the Department of Finance or (2) the total principal apportionment payment the LEA is entitled to receive in July for June.
