Re: California Education Code (EC) 42633 - Verified Signatures

The purpose of this bulletin is to remind you that California Education Code (EC) 42633 states that the governing board of each school district shall be responsible for filing or causing to be filed with the county superintendent of schools the verified signature of each person, including members of the governing board, authorized to sign orders in its name. Except for districts determined to be fiscally accountable pursuant to Section 42650, no order on the funds of any school district shall be approved by the county superintendent of schools unless the signatures are on file in his office and he is satisfied that the signatures on the order are those of persons authorized to sign the order.

Be reminded that it is the responsibility of each District that processes payroll and accounts payable warrants on the Santa Clara County Business System to accurately approve and maintain the appropriate user security access through the Technology Services Branch (TSB) QSS Registration process. Please note that we have added a column for you to add your Authorized Signer for Business System Security and will coordinate this response between departments.
