Re: Publication of Public Hearing for 2014-15 LCAP and Budget

Pursuant to Education Code (EC) 52062(b)(1), school districts are required to hold at least one public hearing to solicit the recommendations and comments of members of the public regarding the specific actions and expenditures proposed to be included in the Local Control and Accountability Plan (LCAP). The public hearing shall be held at the same meeting as the public hearing required by EC 42127(a)(1) for the Budget to be adopted in the subsequent fiscal year.

The agendas for the public hearings for LCAP & Budget Adoption shall be posted at least 72 hours prior to the public hearing. The posting shall include the location where the LCAP and Budget will be available for public inspection. Attached is a form requesting the information necessary for our office to publish, in the newspaper of your choice, the required notice of public hearing. The public hearing will need to be held before the adoption of both the LCAP and Budget.

Please remember to submit your information as early as possible, especially if your district requests the ad be published in a small newspaper. Small newspapers normally need the information from us at least 2 weeks in advance, and they do not publish their newspapers every day.
