- Re: 2015 Calendar Year End Payroll Processing

This bulletin provides important deadline information for the 2015 Calendar Year End Payroll Processing. District Business and Advisory Services (DBAS) will produce the annual *W-2 Employee Wage and Tax Statements* for all Santa Clara County dependent district employees with taxable wages in 2015. In addition, 2015 wage and tax data will be electronically transmitted by DBAS to the Social Security Administration (SSA) as part of the annual W-2 production process. Districts do not need to submit a *Form W-3* for the W-2s to be produced in QCC.

W-2s are created based on final year-to-date data in QCC. However, errors will need to be corrected as DBAS staff reconciles this data. Lists of these errors will be sent to districts by each Advisory team. All errors will need to be corrected during December for timely processing of W-2 forms.

Additionally, there are a variety of year-end "additional compensation" items that may require some special district processing in order to be included on the W-2. Generally, Internal Revenue Service (IRS) publication 15-B requires that all fringe benefits be reported as taxable compensation unless specifically excluded by law. A copy of the latest Publication 15-B is attached for reference. 4
