Re: Publication of Public Hearings for 2016-17 Budget & LCAP

Pursuant to Education Code (EC) 52062(b)(1), school districts are required to hold at least one public hearing to solicit the recommendations and comments of members of the public regarding the specific actions and expenditures proposed in the Local Control and Accountability Plan (LCAP). The public hearing shall be held at the same meeting as the public hearing for the Budget to be adopted as required by EC 42127(a)(1).

The agendas for the public hearings for LCAP & Budget Adoption shall be posted at least 72 hours prior to the public hearing. The posting shall include the location where the LCAP and Budget will be available for public inspection. Attached is a form requesting the information necessary for our office to publish the required notice of public hearing in the newspaper of your choice. The public hearing will need to be held at least one day before the adoption of both the LCAP and Budget.

Please remember to submit your information as early as possible, especially if your district requests the ad be published in a local newspaper with a smaller circulation and staffing. These newspapers usually need the information at least 2 weeks in advance as they do not publish their newspapers every day.
