Re: SCCOE 2016-17 Fiscal Year End Close Calendar Update

The purpose of this bulletin is to update you on a minor change to the Santa Clara County Office of Education's Year End Close Deadlines for Fiscal Year 2016-17. We received a request to work with the County Controller and our Technology Services Branch to push out the deadline for cash transfers as it is a very tight schedule due to how the dates land on the calendar this year. The good news is everyone made an effort to accommodate the request and agreed to extend the July 6th deadline to July 7th for cash transfers between SACS funds and deposit allocations. The new schedule is as follows:
