Re: Year End Cash Transfer Cut-Off and Control Posting Dates

The purpose of this bulletin is to seek your cooperation in a process to help reduce errors in the cash reconciliation and cut-off process for year end cash transfers.

A message will appear for QSS/QCC Users from July 3 to 7, 2017 to inform users that the cut off for Fiscal Year 2016-17 cash transfers is July 7, 2017 at 12:00 PM. Users will be prompted to click on the box that states "I have read the message" before they can use QSS/QCC. Once users are initially notified of the cut-off date and time, a new message will appear on July 7, 2017 at 11:30 AM, 11:45 AM and 11:55 AM, warning QSS/QCC Users to complete and approve any transactions in progress before the 12:00 PM cut-off. Precisely at 12:00 noon, QSS/QCC users will automatically be logged off the "Journals, Transfers (DC,JE, TF,TV) menu. QSS/QCC Users will be able to log back into the "Journals, Transfers (DC, JE, TF, TV) menu at 12:01 PM to perform other transactions.

Please note <u>Cash Transfers (TF)</u> related to Fiscal Year 2016-17 that are processed during the period of <u>July 1</u>, <u>2017 to July 7</u>, <u>2017 noon</u> will have a posting date of <u>June 29</u>, <u>2017</u>. Transactions processed on <u>July 7</u>, <u>2017 at 12:01 PM to August 31</u>, <u>2017</u> will have a posting date of <u>June 30</u>, <u>2017</u>.

July 1 to July 7, 2017 noon	• Includes all cash transfers <u>between</u> funds approved from July 1 up to July 7, 2017 noon,
	and will have a control posting date of June 29, 2017.
July 7, 2017 12:01 PM to August 31, 2017	 Includes all transactions approved from July 7, 2017 12:01 PM to August 31, 2017, and will have a control posting date of June 30th 2017.
	• Use <u>Due From</u> and <u>Due To</u> for any transactions approved after July 7 th , 2017 12:00 PM.
