Re: Reporting Special Compensation for California Public Employees' Retirement Systems

(CalPERS) Members

The purpose of this bulletin is to notify Districts about the change in reporting special compensation for CalPERS members.

Starting December 3, 2016 (the November End of Month payroll) CalPERS will enforce the reporting of special compensation category and type for all Classic and Public Employee Pension Reform Act (PEPRA) members. School Districts are required to identify the category and type of any special compensation or payments made in addition to base pay.

To comply with this CalPERS requirement, the Santa Clara County Office of Education's payroll and financial system (QSS/QCC) has been enhanced to add the list of special compensation categories and types (see attachment #1) to the field 'PSCT' in QCC Pay Lines (PR) screen. For each pay type currently coded with AC-P-C: <u>08-1-6</u>, <u>08-4-6</u>, <u>08-8-6</u>, Districts are required to assign the special compensation category and type from the drop-down menu in the PR screen field 'PSCT' (see attachment #2).

For members with the pay types LOGN and DEGN, Technology Service Branch (TSB) will perform a mass-update to the payroll file to reflect the correct category and type. No action is required for these two pay types.

For all other pay types, please complete the updates to the PR screen by Monday November 21, 2016 at 5:00 PM. If you have any questions, please don't hesitate to contact your DBAS service team.
