Re: Publication of Public Hearing for 2020-2021 Budget and Pending Governor's Executive Order for LCAP

Process

As of April 21, 2020, the California Department of Education (CDE) has not released guidance in the development of 2020-2021 Local Control and Accountability Plan (LCAP) in response to the Governor's Executive Orders to stay-at-home (N-33-20) and waiving all academic assessments for school year 2019-2020 (N-30-20). However, according to the CDE Assessment, Accountability, and Systems of Support webinar on April 21, 2020, it is anticipated that an executive order will be issued to extend the 2020-2021 LCAP submission to mid-December and separate the LCAP and budget adoption process. Therefore, the attached notice of public hearing is prepared to include budget only. If there are any subsequent changes in regulation, our office will notify districts and provide a revised notice.

Pursuant to Education Code (EC) 42127, each school district shall hold a public hearing on the proposed budget for the subsequent fiscal year on or before July 1 of each year. The agenda for the public hearings for the budget shall be posted at least 72 hours prior to the public hearing, while the <u>publication</u> of the dates and location of the budget hearing shall occur no earlier than 45 days before the final date for the hearing but not less than 10 days before the date set for hearing, in accordance with EC 42103.

The posting shall include the location where the budget will be available for public inspection. Attached is a form requesting the information necessary for our office to publish the required notice of public hearing in the newspaper of your choice. The public hearing is required to be held at least one day before the final adoption of the budget.

Please remember to submit your information as early as possible, especially if your district requests the posting be published in a local newspaper with a smaller circulation and staffing. These newspapers usually need the information at least two weeks in advance as they do not publish their newspapers every day.
