Re: Action Required: Refund of Non-Member Contributions from California State Teachers' Retirement

System (CalSTRS)

The District Business and Advisory Services (DBAS) has received the 2nd group of refunds resulting from the CalSTRS data conversion clean up work completed during Spring 2019 (DBAS Bulletin 19-018). Attached is a listing of employer and member contributions as identified by CalSTRS. The detail is presented by district.

ACTION REQUIRED:

Districts and Charters:

- 1. The refund of prior fiscal year employer contribution expenditures should be accounted for as revenue in the current fiscal year (CSAM Procedure 560). Districts are responsible for re-classifying the refunds to an appropriate revenue object code.
- 2. Districts should use Voluntary Deductions code (VD/C) 8112 to return the employee contributions to those individuals who were identified as non-members by CalSTRS.
