Re: Publication of Public Hearings for 2022-23 Budget and LCAP

Pursuant to Education Code (EC) 52062(b)(1), school districts are required to hold at least one public hearing to solicit the recommendations and comments of members of the public regarding the specific actions and expenditures proposed in the Local Control and Accountability Plan (LCAP). The public hearing shall be held at the same meeting as the public hearing for the Budget to be adopted as required by EC 42127(a)(1).

The agenda for the public hearings for the LCAP and the Budget shall be posted at least 72 hours prior to the public hearing, while the <u>publication</u> of the dates and location of the Budget hearing shall occur no earlier than 45 days before the final date for the hearing but no less than 10 days before the date set for hearing as required by EC 42103(d).

The posting shall include the location where the LCAP and the Budget will be available for public inspection. Attached is a form requesting the information necessary for our office to publish the required notice of public hearing in the newspaper of your choice. The public hearing is required to be held at least one day before the final adoption of both the LCAP and the Budget.

Please remember to submit your information as early as possible, especially if your district requests the posting be published in a local newspaper with a smaller circulation and staffing. These newspapers usually need the information at least two weeks in advance as they do not publish their newspapers every day.
