Re: Fiscal Year 2022-23 Attendance Reporting

The purpose of this bulletin is to announce the availability of the 2022-23 Principal Apportionment Data Collection (PADC) Web application for reporting on the California Department of Education (CDE) website at https://pas.cde.ca.gov/. To assist local educational agencies (LEA) in using the PADC web application, the CDE has posted pertinent resources and information on the PADC web page located at https://www.cde.ca.gov/fg/sf/pa/.

Statutory deadlines are listed on the CDE website at: <u>https://www.cde.ca.gov/fg/aa/pa/ataglance2223.asp</u>. Districts and charters must certify the First Principal Apportionment (P-1) attendance data by **January 6, 2023** (Attachment B). A complete submission includes:

- Certified Data in the PADC Web application
- The data entry screen and the Certification Detail pages completely signed and dated by the School District Superintendent and/or Responsible Charter School Official
- Supporting documents (e.g., average daily attendance calculators)

2022-23 Highlights:

- Assembly Bill 130 (Chapter 44, Statutes of 2021; approved on July 9, 2021) and AB 167 (Chapter 252, Statutes of 2021; approved on September 23, 2021) made substantive changes to independent study and, for the *2021–22 school year only*, required school districts and county offices of education to offer independent study as an educational option. The 2022–23 Governor's Budget makes additional changes to the requirements of independent study that local educational agencies (LEAs) shall include in their adopted written policies and implement commencing with the 2022–23 school year. - 2. Assembly Bill (AB) 181 (Chapter 571, Statutes of 2022) and AB 185 (Chapter 52, Statutes of 2022) made significant changes to the Education Code (EC) sections that prescribe school district ADA calculations for the Local Control Funding Formula (LCFF). The following statutory changes impact data collection and funding exhibits for school districts:

- EC 42238.05 changed school district LCFF ADA from the greater of current or prior year reported ADA, to the greater of current, prior, or the average of the three most recent prior years ADA.
- EC 42238.051 was amended, and EC 42238.052 was repealed, which collectively modified the requirements for adjusting prior year ADA for a school district in cases where students transfer between non-charter schools of the district and district sponsored charter schools.

• EC 42238.02(g)(2) - New LCFF add-on funding for Transitional Kindergarten (TK) ADA For a detailed explanation of how these changes impact data collection, please refer to **Attachment D** – **ESSCO December 2022 Publication of School District ADA Changes for 2022–2023** at the bottom of this document.

Each entity reporting data must certify the record in order for it to move forward to an oversight entity certification, and subsequent transfer to the CDE. A PADC Administrator is the only user role with permission to certify data records. Certification acts as the seal on the record; therefore, data cannot be edited after the reporting entity certified the record. Please contact the oversight entity Administrator (Attachment A) to remove the original certification if you would like to make edits after certification.

School District ADA Changes for 2022-

23

Assembly Bill (AB) 181 (Chapter 571, Statutes of 2022) and AB 185 (Chapter 52, Statutes of 2022) made significant changes to the *Education Code* (*EC*) sections that prescribe school district ADA calculations for the Local Control Funding Formula (LCFF). The following statutory changes impact data collection and funding exhibits for school districts:

- *EC* 42238.05 changed school district LCFF ADA from the greater of current or prior year reported ADA, to the greater of current, prior, or the average of the three most recent prior years ADA.
- *EC* 42238.051 was amended, and *EC* 42238.052 was repealed, which collectively modified the requirements for adjusting prior year ADA for a school district in cases where students transfer between non-charter schools of the district and district sponsored charter schools.
- EC 42238.02(g)(2) New LCFF add-on funding for Transitional Kindergarten (TK) ADA

Data Collection Changes

Changes to the Attendance School District data collection are minimal in 2022–23. Following are descriptions of key changes to the data collection, which are also included in the 2022–23 Principal Apportionment Data Collection (PADC) User Manual.

Transitional Kindergarten

On the new Line A-0, school districts must answer "YES" or "NO" to the following question: "Does the school district have Transitional Kindergarten (TK) ADA to report?" School districts with TK ADA to report will continue to report the TK ADA with TK/K-3 ADA online A-1, and separately online B-5.

Charter Shift Adjustments

AB 181 (Chapter 52, Statutes of 2022) amended *EC* requirements for adjusting prior year school district ADA in cases where students transfer between non-charter schools of the district and district sponsored charter schools. The Attendance School District data entry screen has been revised accordingly, as follows:

 Previously, school districts reported the lesser of the prior year or current year P-2 ADA for each student transferring to or from charter schools sponsored by the district. Effective FY 2022–23, school districts should report just the prior year P-2 ADA for students transferring either to or from charter schools sponsored by the district. Additionally, the net adjustment to a school district's prior year ADA as a result of these transfers, as calculated by the CDE, may now be positive or negative. Previously the adjustment could only be negative. Previous reporting requirements specific to a charter school conversion to a school of the district are retired per *EC* 42238.052. Therefore, the separate ADA reporting on former lines C-7 through C-9 has been removed. If the school district operates a noncharter school in the current year that operated as a charter school of the district in the prior year, the district should report the prior year P-2 charter school ADA attributed to students attending a non-charter school of the district in the current year in Lines C-4 and C-5.

Charter Shift Reporting Example

Adjustments to the prior year ADA are reported each year. In 2022–23, school districts will report 2021–22 ADA for certain students which will result in adjustments to the district's prior year ADA for purposes of calculating the greater of current, prior or three prior years' average ADA. Prior year ADA adjustments reported in 2022–23 will be used in all subsequent years that use 2021–22 ADA in calculating school district's LCFF ADA, as follows:

School District Reorganization Adjustments

Adjustments for Gain or Loss of ADA Due to a Reorganization or Transfer of Territory (Lines C-7 to C-15): This section has been expanded to capture adjustments for the three most recent prior years, in accordance with the new school district ADA calculations in *EC* 42238.05. School districts should contact the CDE at <u>PASE@cde.ca.gov</u> for guidance before reporting ADA in this section.

It is important for the school district and/or the COE to reach out to CDE prior to reporting because some adjustments of this type are reported by the districts, while others, such as in the case of school district lapsation are calculated by the CDE from the data previously reported by affected school districts.

Funding Exhibit Changes

Following are descriptions of key changes to the School District ADA funding exhibit in 2022–23.

Layout

The main changes to the exhibit layout are 1) the addition of new sections for second and third prior year ADA, and 2) the display of four grade spans and ADA totals in columns (Grades TK/K-3, Grades 4-6, Grades 7-8, Grades 9-12).

Necessary Small School (NSS) ADA

NSS ADA is funded under a different model than the LCFF Base Grant. Beginning in 2022–23, there will be a change in how NSS ADA is displayed in the prior year sections.

- 2021–22 and prior: The School District ADA exhibit started with prior year ADA, net of NSS ADA. If any NSS changed status from NSS to base grant or vice versa, a positive or negative adjustment is displayed in the "Adjustment of ADA due to Change in Status of a Necessary Small School" section (previously Lines A-26 to A-30).
- Beginning 2022–23: Each prior year ADA section will begin with total school district ADA including NSS, then subtract NSS ADA, which eliminates the need for NSS Change in Status lines.

Charter Shift Adjustments

As described in the data collection section above, there were changes to charter shift adjustments that will be reflected in the School District ADA exhibit.

The net adjustment to a school district's prior year ADA as a result of charter shift transfers, as calculated by the CDE, may now be positive or negative. Previously the adjustment could only be negative. These adjustments will be displayed as "Charter School Shift Increase" and "Charter School Shift Decrease" in each prior year section on the exhibit.

- Charter School Shift Increase [EC 42238.051(a)(2)(B)(i)] represents the respective prior year ADA for students attending a non-charter school of the district in the current, prior, or second prior fiscal year, who attended a charter school sponsored by the district in the respective prior year.
- Charter School Shift Decrease [EC 42238.051(a)(2)(B)(ii)] represents the respective prior year ADA for students attending a charter school sponsored by the district in the current, prior, or second prior fiscal year, who attended a non- charter school of the district in the respective prior year.

Note, in 2022–23 there will be no charter shift adjustments to the second and third prior years, and in 2023–24 there will be no charter shift adjustments to the third prior year, as that data was not collected in 2020–21 or 2021–22 [*EC* 42238.051(a)(2)(B)(v) and 42238.051(a)(2)(B)(vi)].

Previous reporting requirements specific to a charter school conversion to a school of the district are retired per *EC* 42238.052. These positive charter shift adjustments will now be reflected in the applicable "Charter School Shift Increase" line.

Average ADA of Three Prior Years

There is a new calculation for the average ADA of the three most recent prior years, pursuant to *EC* 42238.05. This section also includes new calculations for a prior year and second prior year "charter school shift percentage" pursuant to *EC* 42238.051(a)(2)(B)(vii), which says:

"(vii) Notwithstanding clauses (v) and (vi), if in any fiscal year the adjustments described in clauses (i) and (ii) result in a 50 percent or greater reduction of the school district's second period attendance for the prior or second prior fiscal year, the school district's average second period attendance for the three most recent prior fiscal years shall be zero."

In simple terms, *EC* 42238.051(a)(2)(B)(vii) says that a school district shall not be funded on the three prior year average ADA if the district had more than 50 percent of their ADA shift from non-charter schools to district sponsored charter schools in the current year or the prior year. New Lines A-22 and A-23 calculate the percentage of net charter shift ADA compared to total ADA (excluding NSS ADA) for both the prior and second prior years. If the percentage calculated is less than -50 percent, then the average ADA for the three prior years will be zero, and the district will be funded on the greater of current or prior year ADA.

All-Charter Districts

The exhibit has updated calculations for all-charter districts to fund resident ADA (regular and extended year special education) on the greater of current, prior, or three prior year average, pursuant to *EC* 47613.1. Non-resident ADA will continue to be funded on current year ADA only.
