Topics: Creditable Service, Defined Benefit Membership, Creditable Compensation, and Working After Retirement

9:00 – 10:30 a.m.	Creditable Service Training This course covers the topic of creditable service. You will learn how to recognize the requirements of creditable service, identify service that is creditable, and explain the grandfathering of misreported service.
10:30 – 10:45 a.m.	Break 15-minute break
10:45 – 12:00 p.m.	Defined Benefit Membership Training This course covers the topic of Defined Benefit (DB) membership. Defined Benefit membership shows how an employee becomes a CalSTRS member, or if they are already a member, how they keep their retirement contributions with CalSTRS.

	This course covers the topic of creditable compensation. You will learn the conditions that make compensation creditable, the types of compensation that are reportable, and how to report compensation using the appropriate annualized pay rate.
