Re: Classified School Employee Summer Assistance Program (CSESAP): Final State Match Funding for the

2024-25 School Year

The purpose of this bulletin is to inform districts that are participating in the Classified School Employee Summer Assistance Program (CSESAP) that the California Department of Education (CDE) has revised the allocation of state match funding for the 2024-25 school year.

Based on the data reported by the local educational agencies (LEA), the final state match funding is eighty-one and nine-tenth cents (\$0.819) for each one dollar (\$1) withheld from participating employees during the 2024-25 school year. The letter and schedule of the first apportionment will be available in September 2025.

For Santa Clara County, the final total state match funding of \$5,549,667 will be made available for participating school districts. Please see the following pages for the details of the state match funding by district for the school year 2024-25.

Final Amount of State Match Funding

2024-25 School Year

Fiscal Year 2022–23, 2023–24, 2024–25

- 1) The remaining appropriation balance from Section 139 of Assembly Bill (AB) 181 (Chapter 52, Statutes of 2022) is \$2,408,639, and can be used to support the 2024-25 school year pursuant to Education Code 45500(k).
- 2) The Budget Act of 2023-24 Senate Bill (SB) 101 (Chapter 12, Statutes of 2023) appropriates \$90,000,000 to provide state match funding to support the 2024-25 school year.
- 3) The Budget Act of 2024-25 as amended by Sec. 213 of SB 108 (Chapter 3, Statutes of 2024) appropriates \$99,000,000. Of this amount \$14,593,745, will support the 2024-25 school
- 4) The state match is \$0.819 for each \$1 withheld from participating classified employees, for the 2024-25 school year.
