Re: Fiscal Year End 2011-12 Critical Deadlines Reminder

The purpose of this e-mail is to remind you of the upcoming Cricital Fiscal Year End Deadlines for the months of June 2012 through September 2012.

The first upcoming deadline is on *Friday, June 29, 2012*. The cutoff time for fiscal year 2011-12 deposits is 11:45 a.m. with the Tax Collector's Office Cashiering Unit or 5:00 p.m. with Bank of America on *Friday, June 29, 2012*. Deposits received after these cutoff times will be dated July 1, 2012 and treated as fiscal year 2012-13 revenue.

Please also be advised that the last day to make cash transfers between funds for fiscal year 2011-12 is on *Friday, July 13, 2012*. Transfers made between funds after July 13<sup>th</sup> must be set up as due to/due from.
