Key Updates:

- Due Date for all proposals pushed out to **3:00pm, Friday, Aug 19, 2022**
- The proposals should no longer include any design for the meeting room space at the South County Annex in Gilroy. This room has been assigned a new function and will no longer be in scope for this RFP.
- Please change your proposals to include the Conference Center overflow capabilities to the Multi Purpose Room instead of the Meeting Room.
- All proposals should include a full diagram of electrical and low voltage wiring requirements. Based on those requirements a separate RFP for Public Works will be published.

Q&A:

Gilroy Location Questions

- Do we know what size table and what slots will be available for power/av cables, etc. in the Meeting Room at South County Annex?
 - The meeting room at South County Annex is no longer to be included as part of the RFP
- Will there be power to the floor already in the Meeting Room at the South County Annex?
 - The meeting room at South County Annex is no longer to be included as part of the RFP.
- Do the ceilings have raceways at all locations?
 - No, but we will need to follow code in all designs for low voltage cable requirements.
- Are the 'As Built' that can be provided for the spaces?
 - We are providing floor plans for both locations as requested.
- Can we use IDF for main AV equipment rack?
 - Yes, as long as it meets code on electrical requirements for the space.
- Will there be any patching or painting required?
 - No, all of this will be covered by a separate RFP for Public Works.
- Confirming if any cable pulls will be needed?

- All bids should include drawings of exact location and requirements for electrical and low voltage requirements. These will be provided based on separate public works RFP. If your design requires additional cables not covered by these areas then you should include it in your bid.

Ridder Park Questions

- Is there networking between San Jose and Café?
 - There currently is not but, the network team can extend any network segment to there as needed/requested. Please include what you need in your design.
- Can we pull a Multi Node Fiber strand?
 - We do have room to pull fiber if the design requires it. Please include this in your proposal if you need this as part of your design.
