- **Notice:** Notice is hereby given that the Board of Trustees of the Santa Clara County Office of Education (hereinafter referred to as (SCCOE)), is requesting bids from interested vendors to provide bid for **THE ABOVE LISTED E RFP**.

The Santa Clara County Office of Education is seeking pricing on a 1-Year subscription license for our existing WYEBOT equipment (L-1001_NO) with two one-year extension options.

No offer of intent should be construed from this legal notice that the (SCCOE) intends to enter a contract with the interested company for the **ABOVE LISTED RFP** unless, in the sole opinion of the (SCCOE), it is in the best interest of the (SCCOE) to do so. The (SCCOE) reserves the right to negotiate final contractual terms with the lowest responsive bidder.

- **Job Walk:** There will be no job walk.

Submittal: Written RFPs must be sealed and filed with the (SCCOE) at the address shown above no later than **3:00 p.m., Friday, February 2, 2024**, at which time the SCCOE will publicly open and read received RFPs. Responses are requested as three hard copies. **The received RFPs can be hand delivered or sent via mail only.** Any RFP received after the RFP deadline shall be returned to the bidder unopened.

- **Required Contractor License:** The class(es) of California contractor's license(s) required to bid on and perform the contract for this Project is **General Contractor's License or C12 license**.
- **Required Bid Security:** Each RFP must be submitted with security in an amount not less than ten percent (10%) of the maximum RFP amount as a guarantee that the bidder will enter the proposed contract, if awarded to the bidder, and will provide the performance and payment bonds, insurance certificates and other documents described in the Contract Documents. Such security must be in one of the following forms: (1) a cashier's check made payable to the SCCOE; (2) a certified check made payable to the SCCOE; or (3) a bond made payable to the SCCOE in the form set forth in the Contract Documents. Any bond must have been issued by a California-admitted surety as defined in Code of Civil Procedure Section 995.120
- **Withdrawal:** Companies may not withdraw proposals for a period of sixty (60) days after the date set for opening of proposals.
