March 22 SCCSBA Zoom Meeting (7:00PM Start Time)

Because we received feedback people wanted time for questions for our panels last year, for this meeting's panel discussion we are starting our meeting a little earlier than usual (when we would have meet and greet in person pre-Covid). Please join us at 7:00pm on zoom.

It's the time of year to elect officers, we will have some quick updates, followed by Westmont HS students' suggestions on the implementation of the *Menstrual Equity for All Act*. After that, we are partnering with the Santa Clara County Office of Education to offer our members a candid conversation about hate crimes on school campuses. How can we as trustees learn from one another on this sensitive topic without making anyone feel as though we are sitting in judgment? When hate crimes occur, how do we weigh our response when not responding may make the intended victims (or members of the learning community) feel further victimized, but responding in a very public way may fuel copycats (because any attention is attention)? How do we support students and staff, and build community, without "other-ing" them? What tools are (or should be) available to trustees and districts to prevent or respond to hate crimes?

Two students, a superintendent, and a board member from Los Gatos Saratoga Union High School District will discuss the topic of hate crimes on school campuses based on their personal experiences. Olivia Santillan, SCCOE's History and Social Science Content Expert, will join the conversation and provide thoughts about restorative practices in this area as well as curricular resources that are currently available. County Superintendent Dr. Mary Ann Dewan will introduce the panel and will field your questions for the panelists through the chat. Dr. Anisha Munshi, SCCOE Associate Superintendent of Equity and Educational Progress, Continuous Improvement and Accountability, The Inclusion Collaborative, and Public Affairs, will moderate the discussion. A mental health provider will be available in a breakout room if anyone becomes distressed due to the discussion and needs support.

CSBA Spotlight (csba.org)

The Department of Finance has released trailer bill language for Gov. Gavin Newsom's January budget, including the education omnibus trailer bill, providing more detail on the Governor's proposed 2023–24 TK-12 education budget.

The trailer bill hones in on major provisions of the Governor's proposal as budget hearings in the Legislature begin, while a new analysis from the Legislative Analyst's Office warns that more education cuts may be necessary.

One-time funds and arts grant reduction proposed to fully fund COLA

The Governor's budget includes an 8.13 percent cost-of-living adjustment (COLA) for the Local Control Funding Formula. To fully fund the increase, the proposed trailer bill uses \$1.4 billion in one-time funds to pay for ongoing LCFF costs and makes a \$1.2 billion reduction in the Arts, Music, and Instructional Materials Discretionary Block Grant included in the current year Budget Act of 2022. Funding from the grant is discretionary and many districts have already made plans for their use — from buying down retirement obligations and health benefits to purchasing instructional materials — posing challenges should the Legislature agree to the reduction.

Details provided on LCFF Equity Multiplier

The trailer bill language provides further detail on the Governor's proposed LCFF Equity Multiplier. Starting in 2024–25, the trailer bill provides \$300 million in ongoing Proposition 98 General Fund with a COLA provided in future years. Funds will be provided to local educational agencies as an add-on to the LCFF based on the prior year enrollment of eligible school sites. Eligible school sites include those serving grades TK-8 with at least 90 percent of youth eligible for free and reduced-price meals under the federal National School Lunch Program definition in the prior year, or those serving grades 9-12 with at least 85 percent of students eligible.

Funds provided by the Equity Multiplier must supplement, not supplant, existing LCFF expenditures for eligible school sites and no eligible school site will receive less than \$50,000.

Four exceptional MUSD leaders honored with ACSA Region 8 Awards

Region 8, which is Santa Clara County, has announced its awardees, and four of them are MUSD leaders: Giuliana Brahim (Adult Education Administrator of the Year), Mary Jude Doerpinghaus (Student Services Administrator of the Year) and Kelly Ng (Classified Administrator of the Year) and Cheryl Jordan (Superintendent of the Year).

"Each of these exceptional leaders are an integral part of our MUSD team," said Supt. Jordan, who has devoted her decades-long educational career to the staff, students and families of Milpitas. "They set the bar for leadership in their respective departments and are more than deserving of this amazing honor."



Morgan Hill Unified School District

Pilar Vazquez-Vialva, Assistant Superintendent of Educational Services for the Morgan Hill Unified School District (MHUSD), has been named the ACSA Region 8 Outstanding Administrator of the Year in the area of Curriculum and Instruction.

Pilar is a champion for equity, considering the needs for all students and addressing a system that may inadvertently place barriers to

success for some students. Pilar has brought the National Equity Project to Morgan Hill, inviting a number of administrators and teachers to join in the work. In December of 2022, Pilar received a letter that based on her work with Building Equitable Learning Environments (BELE) Network with the National Equity Project, MHUSD is considered for a visit from the US Department of Education in 2023 to spotlight at least eight leading school districts across the country that are making meaningful investments in innovative, evidence-based policies and practice that center whole-child learning and development and can be elevated as exemplars for the broader education ecosystem.

In Morgan Hill, Pilar is leading the work to create a commitment and ways of working aligned with the whole child, especially opening Wellness Centers and spaces at all our campuses, creating a student-voice BELE council at the high schools - a safe place to discuss race, discrimination, bias, and other challenging topics from the students' experiences, creating a "9th Grade on Track" focused counseling program at the high schools, and creating and offering an innovative summer option "Freshman Success" for all in-coming 9th-grade students. She is committed to ongoing training in the areas of MTSS and Restorative Justice.

We congratulate Pilar on her well-deserved recognition. Our students and staff are grateful for your leadership and the inspiration to make a positive impact on the students we serve.
